Progress

Conservation of Big Feline Species

- ✓ **Ongoing implementation** of Project "Transboundary cooperation on the conservation of Amur tigers, Amur leopards and Snow leopards in North-East Asia"
 - ✓ (1) Transboundary cooperation between the Northeast Tiger and Leopard National Park (China) and the Land of the Leopard National Park (Russian Federation) to conserve Amur tigers and leopards <u>ongoing (by end 2023)</u>
 - ✓ (2) Transboundary cooperation between neighboring protected areas in Lesser Khingan Mountains to conserve Amur tigers <u>completed</u>
 - ✓ (3) Assessment of the current status of two snow leopard subpopulations in the Transboundary area between Mongolia and the Russian Federation <u>completed</u>

 - ✓ Shared 20 best practices in areas of (1) climate action planning, (2) energy and building, (3) mobility and infrastructure, (4) green finance and (5) stakeholder engagement in climate action
- Training workshop on STI for Low Carbon and Resilient Cities
 - ✓ Ulaanbaatar, Mongolia/ Hybrid/ 16-17 Dec 2021
 - ✓ Joined by 80 local trainees from relevant ministries and departments and local districts in major cities in Mongolia, and diverse stakeholders
 - ✓ Shared good practices in different sectors for advancing sustainable, inclusive and resilient societies through STI application, responding to the priority needs of trainees

Item 5(e) Desertification and Land Degradation

The stock-taking study on the interlinkage of DLD and climate change

- a. Examined the existing scientific assessment on carbon emissions from land use change and management in North-East Asia
- b. Reviewed main assessment results based on different methodologies
- Identified gaps in the assessments, policy implications for mitigating carbon emissions and areas for collaborative work within scientific community and between countries
- d. Suggested recommendations for subregional approach

The study on climate change and desertification, land degradation and drought in North-East Asia

- a. Secretariat worked with ESCAP ICT and Disaster Risk Reduction Division (IDD) to assess desertification, land degradation and drought risks, and studied their potential socio-economic impacts in North-East Asia
- b. Highlighted the need (a) to learn and understand the nature, extent, and magnitude of the risk and the vulnerability of the society, the environment and the economy, (b) build resilience and (c) develop long term proactive measures
- c. Proposed intergovernmental cooperation measures

Consultation meeting with the DLDD-NEAN Secretariat on 10 June 2022

DLDD-NEAN Secretariat recommended that NEASPEC focus on addressing DLD issues in connection to other related sectors (tackling the potential causes of DLD), such as water resources management, agriculture, animal husbandry, energy, etc., while DLDD-NEAN addresses DLDD issues within the forestry sector.

Background

- NEASPEC independent evaluation (2020) recommended updating NEASPEC's long-term vision, mission and goals to align NEASPEC with the ambition and intention of its member States.
- SOM-24 decided to hold a National Focal Point meeting to develop and agree on an implementation plan for addressing the evaluation recommendations.
- The NFP meeting (May 2021) generally agreed to develop a renewed commitment document, while the necessity would be further reviewed and decided by the SOM-25.
- The SOM-25 is expected to decide on the necessity of adopting a renewed commitment document and agree on the structure, key elements and timeline of such document if the SOM agrees to proceed.
