Annotated Provisional Agenda

1. Opening of the meeting

Opening and welcoming remarks will be delivered, followed by the introduction of participating SPC and TC members.

2. Election of officers

A chair and a vice-chair will be elected. The Rules of the Procedure for the NEACAP Science and Policy Committee stipulates to elect a chair and vice-chair at the commencement of each meeting, who will hold office until the next regular meeting.

3. Adoption of agenda

The provisional agenda will be considered and adopted by the meeting, subject to such changes as may be necessary.

4. Review of follow-ups on the outputs of NEACAP SPC-4¹

The Committee will review the progress and plans of (1) the policy analysis report/the policy dialogues and (2) voluntary BAT collaboration and discuss a work plan for 2023 and 2024. The review and discussion will be based on a secretariat presentation during the session.

5. Mid-term review of the NEACAP Work Plan 2021-2025

SPC-4 recommended conducting the mid-term review of NEACAP in 2023. Noting paragraph 7 of the NEACAP Workplan 2021-2025,² SPC-4 suggested the secretariat consider preparatory
